

## Monitoring and Evaluation Course Description

### Monitoring and Evaluation for Program Managers

Program and project managers at subnational, program, and facility levels need systematic data to help them with their management tasks, such as improving program performance, making staffing decisions, effectively allocating resources, determining the future direction of programs, and providing timely feedback to donors and stakeholders.

#### **Description**

In response to requests from the field for monitoring and evaluation (M&E) training for program managers, the M&E Team of the Centers for Disease Control and Prevention/Global AIDS Program contracted with Macro International Inc. to assist in the development of Monitoring and Evaluation for Program Managers. This course provides participants with a thorough grounding in the use of M&E for addressing the practical management responsibilities encountered in HIV prevention and care programs. Participants learn how to:

- relate M&E concepts and processes to their everyday practical program needs
- use M&E data to more effectively manage programs and resources.

The facilitator provides technical assistance for the course's featured activity: the development of an M&E action plan tailored to each participant's program. This action plan includes:

- a logic model
- a summary of high-priority data needs associated with specific uses of those data
- a description of data flow
- a plan for allocating staff and resources to these activities
- a timeline.

#### **Audience and Format**

This course is designed for program and project managers who have little or no background in M&E and who work in one or more of the following types of programs:

- Subnational- or district-level HIV/AIDS initiatives
- HIV/AIDS programs and projects within nongovernmental, community-based, or faith-based organizations
- HIV/AIDS workplace programs
- Programs funded through multilateral and bilateral organizations
- Programs supported by national ministries and national AIDS councils
- Special prevention, care, and support programs (e.g., home-based care, orphans and vulnerable children).

The module-based course is led by a facilitator and can accommodate up to 25 participants. The modules use presentations, case studies, interactive activities, and small and large group discussions to teach and reinforce course concepts. Although the course is designed to be delivered in 4 or 5 days, it can be tailored to the needs of individual countries and programs on the basis of the audience's needs and time constraints.
